## To Watch Out For

Keep an eye out for the following impending changes in the law:

- **Intellectual Property** - Amendments to the Copyright, Designs and Patents Act 1988 in respect of musical and literary works, will take effect from 1 November 2013. [More](#)
- **Regulatory** - Restrictions around the use of an insecticide called Fipronil are due to take effect from 31 December 2013. [More](#).
